ORDINANCE NO. 508 SERIES 2011

AN ORDINANCE RELATING TO DUTIES OF APPOINTED OFFICERS.

WHEREAS, the Town of Dolores has the need to enforce its ordinances relating to animal control, nuisances, weeds, trash, rubbish and other matters, and

WHEREAS, because of budget constraints the Town is unable to hire additional staff for this purpose so it is necessary to utilize existing Town employees as Code Enforcement Officers when necessary and such enforcement officers are necessary for the public safety and welfare.

NOW THEREFORE, it is ordained by the Board of Trustees of the Town of Dolores, Colorado:

Section 2.04.040 A. <u>Duties</u>, <u>Dolores Municipal Code</u> shall be repealed and replaced with 2.04.040 A. <u>Duties</u>:

- A. The Board of Trustees may appoint by resolution:
 - 1. an Animal Control Officer or Officers
 - 2. a Building Inspector
 - 3. a Weed Control Officer or Officers

4. a Code Enforcement Officer or Officers empowered to act as Animal Control Officer and Weed Control Officer and to perform such other code enforcement duties as may be assigned by the Town Manager.

Repealer. All orders, bylaws, ordinances, and resolutions of the Town, or parts thereof, inconsistent or in conflict with this Ordinance, are hereby repealed to the extent only of such inconsistency or conflict.

<u>Severability</u>. If any section, paragraph, clause, or provision of this Ordinance shall for any reason be held to be invalid or unenforceable, the invalidity or unenforceability of such section, paragraph, clause, or provision shall not affect any of the remaining provisions of this Ordinance, the intent being that the same are severable.

<u>Recording and Authentication</u>. Upon adoption hereof, this Ordinance shall be recorded in a book kept for that purpose and shall be authenticated by the signatures of the Mayor and the Town Clerk.

<u>PUBLIC HEARING</u>. This ordinance shall be considered for second or final reading on the 11th day of July, 2011, at the hour of 6:30 p.m. in the Town Board Chambers in Town Hall, Dolores, Colorado, at which time and place all persons may appear and be heard concerning the same.
