

**ORDINANCE NO. 534
SERIES 2018**

**AN ORDINANCE REPEALING CERTAIN CHAPTERS AND SECTIONS OF THE
CRIMINAL ORDINANCES, THE DOLORES MUNICIPAL CODE**

WHEREAS, it becomes necessary to review and revise the Dolores Municipal Code based on revisions or changes to Colorado State Law; and,

WHEREAS, recent revisions to State Law regarding Municipal Courts, jail sentences and other matters make this an opportune time to review and simplify the Criminal Sections of the Dolores Municipal Code.

NOW THEREFORE, BE IT ORDAINED BY TOWN OF DOLORES BOARD OF TRUSTEES THAT:

Title 9 Chapter 9.04 Offenses Against Government is repealed in its entirety.

Chapter 9.08 Section 9.08.20 Keeping a disorderly house prohibited is repealed.

Chapter 9.12 Offenses Against Public Decency is repealed in its entirety.

Sections 9.12.010 Bawdy houses prohibited and,

Sections 9.12.020 Keeping a bawdy house prohibited and,

Sections 9.12.030 Indecent materials prohibited and,

Sections 9.12.042 Underage consumption of marijuana and,

Sections 9.12.043 Underage consumption of alcohol are repealed in their entirety.

Chapter 9.16 Offenses Against Property is repealed in its entirety.

Chapter 9.20 Offenses Involving Minors is repealed in its entirety.

Chapter 9.24 Gambling is repealed in its entirety.

Chapter 9.28 Weapons is repealed in its entirety.

Chapter 9.32 Fireworks and Explosives is repealed in its entirety.

Repealer. All orders, bylaws, ordinances, and resolutions of the Town, or parts thereof, inconsistent or in conflict with this Ordinance, are hereby repealed to the extent only of such inconsistency or conflict.


Severability. If any section, paragraph, clause, or provision of this Ordinance shall for any reason be held to be invalid or unenforceable, the invalidity or unenforceability of such section, paragraph, clause, or provision shall not affect any of the remaining provisions of this Ordinance, the intent being that the same are severable.

Recording and Authentication. Upon adoption hereof, this Ordinance shall be recorded in a book kept for that purpose and shall be authenticated by the signatures of the Mayor and the Town Clerk.

PUBLIC HEARING. This ordinance shall be considered for second or final reading on the 12th day of February, 2018, at the hour of 6:30 p.m. in the Town Board Chambers in Town Hall, Dolores Colorado, at which time and place all persons may appear and be heard concerning the same.


