The first steps in developing a Strategic Plan are to:

- Agree to the Vision Statement. The vision statement was developed during our facilitated session in July, but we can edit if you wish.
- Agree to Broad Goals and then the Objectives -Goals are meant to be broad statements of purpose and not detailed descriptions of Actions.
- Agree to Objectives that are statements that actualize the Goals.
