If another candidate for the same office refuses to accept the spending limit, **the accepting candidate shall have ten (10) days in which to withdraw acceptance.** The accepting candidate shall have this option of withdrawing acceptance after each additional non-accepting candidate for the same office enters the race; or
2. **The applicable contribution limits shall double** for any candidate who has accepted the applicable voluntary spending limit, **AND** the non-accepting candidate has raised more than ten percent of the applicable voluntary spending limit.
